A) IDFC Club Internals

A.1) UN Secretary-General Bank Ki-Moon attended the Annual Meeting of IDFC

During the occasion of the 2nd Annual Meeting of IDFC, the Secretary-General of the United Nations Ban Ki-Moon met with our IDFC CEOs. The Annual Meeting topics of the Meeting were the 2013/2014 work program in climate and development finance as well as IDFC's strategic profile.

In his key note speech to the IDFC CEOs, the UN Secretary-General Ban Ki-Moon stated: "Development banks within the IDFC have provided impressive green finance commitments, including \$79 billion in climate financing in the last year alone". He encouraged members of the IDFC to further increase their climate financing and to continue their efforts in mobilising additional private capital and to use the 2014 Climate Summit to reach the goal of \$100 billion-a-year for new climate finance commitments. "Your capital and your strategic collaboration across very different parts of the world can create and transform markets. With enlightened action, we can create jobs, improve public health and protect the environment", he said.

The new cooperation between IDFC and UN is structured to foster the engagement in climate finance. Especially the inclusion of the private sector in the field of climate finance in developing countries is considered as a focal point of the collaboration.

A.2) Review: IDFC Steering Group Meeting & Annual Meeting in Washington D.C.

This year's Annual Meeting and Steering Group Meeting took place along with the Annual Meetings of the World Bank Group and the International Monetary Fund on October 13 in Washington D.C. at the "Metropolitan Club". The solid convention within IDFC's every year's calendar aimed to assess on the Club's current course and to inform on latest working progresses. Major points on the agenda besides the gathering with the UN Secretary-General were the mission and vision of IDFC and sustainable urban development.

A.3) New IDFC Workstream: Sustainable Urban Development

The Members of IDFC considered the topic "sustainable urban development" as a major issue for future development in the light of tendencies towards urbanization, especially in the developing world.
