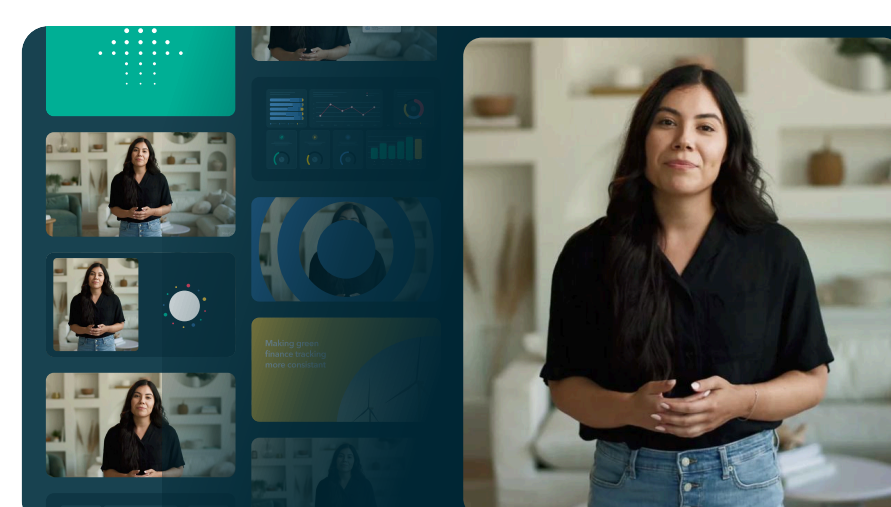
- **Annual dedicated workshops**

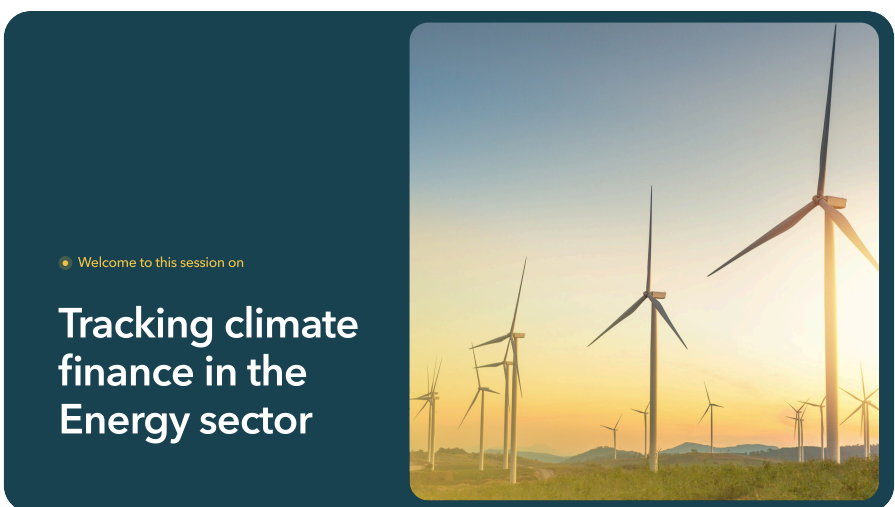

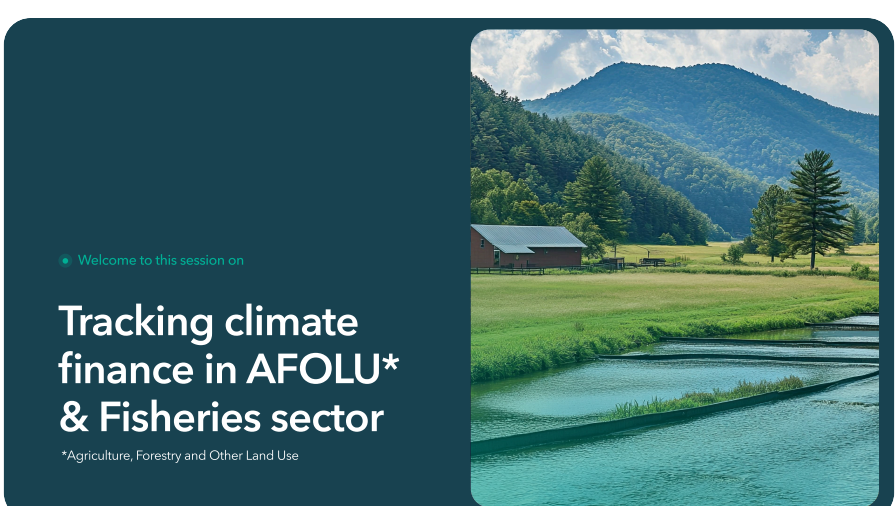
